

MIRANDA RIGHTS EVIDENCE FORM

PRINT THIS FORM AND CARRY IT WITH YOU IN CASE YOU ARE CONTACTED BY THE POLICE OR ARRESTED.

1. I HAVE THE RIGHT TO REMAIN SILENT AND HEREBY ADVISE YOU TO STOP ALL QUESTIONING UPON THE ADVICE OF MY ATTORNEY.
2. MY ATTORNEY IS JOHN J. CARNEY AND I WISH TO HAVE HIM PRESENT BEFORE ANY FURTHER QUESTIONS ARE ASKED. HIS PHONE NUMBER IS 917-696-2363. I WISH TO CALL HIM NOW.
3. IF I CANNOT AFFORD AN ATTORNEY YOU MUST PROVIDE ME ONE WITHOUT COST.
4. I WILL NOT RESIST ARREST, NOT WILL I ANSWER QUESTIONS, EVEN IF YOU HANDCUFF, ARREST, DETAIN, PROMISE, OR THREATEN ME.
5. I DO NOT GIVE YOU PERMISSION TO SEARCH MY PERSON, VEHICLE, PROPERTY, OR ANY OTHER PROPERTY THAT I HAVE AN EXPECTATION OF PRIVACY IN AND IF YOU HAVE A WARRANT SIGNED BY A JUDGE I WILL ALLOW A SEARCH AND NOT RESIST OR OBSTRUCT JUSTICE, BUT ONLY IF YOU SHOW ME SUCH SEARCH WARRANT FIRST.
6. THIS DOCUMENT WILL ACT AS EVIDENCE IN COURT THAT I DID NOT MAKE ANY STATEMENTS OR GIVE ANY CONSENT TO SEARCH. (IN A PUBLIC HOUSING PROJECT GIVE THE NAME AND APARTMENT VISITED)
7. NO MATTER WHAT YOU SAY, OR WHAT YOU THREATEN, I WILL NOT GIVE UP MY CONSTITUTIONAL RIGHT TO REMAIN SILENT, NO MATTER HOW LONG YOU DETAIN ME.
8. MY NAME IS _____. MY ADDRESS IS _____. MY DATE OF BIRTH IS _____. MY ATTORNEY'S NAME IS _____. MY ATTORNEYS' PHONE NUMBER IS _____. I WISH TO CONSULT WITH HIM BEFORE I DECIDE IF I WILL TAKE ANY SCIENTIFIC TEST, INCLUDING BREATH, BLOOD, OR OTHER TEST, I WILL NOT SAY WHERE I WAS OR WHERE I AM GOING.
9. I RESPECTFULLY DEMAND THAT ALL QUESTIONING STOP UNTIL MY ATTORNEY IS PRESENT, EVEN IF I AM NOT IN CUSTODY, ACCUSED OF A CRIME, OR IF YOU TELL ME THAT I WILL RECEIVE FAVORABLE TREATMENT FOR TALKING WITHOUT AN ATTORNEY OR IF YOU CLAIM THAT YOU WILL BE LENIENT OR OFFER A BENEFIT IF I TALK TO YOU. ANY DEAL THAT IS MADE WILL BE MADE WITH MY ATTORNEY PRESENT.
10. I UNDERSTAND THAT THE SUPREME COURT HAS GIVEN YOU THE RIGHT TO LIE TO ME, DETAIN ME, OR TRICK ME INTO MAKING STATEMENTS, AND THAT IS WHY I WILL NOT ANSWER ANY QUESTIONS UNTIL YOU PROVIDE ME WITH AN ATTORNEY FREE OF CHARGE. YOU CAN CALL LEGAL AID OR MY PERSONAL ATTORNEY AND I WILL REMAIN IN CUSTODY UNTIL AN ATTORNEY IS PROVIDED.
11. I WILL SIGN AND DATE THIS DOCUMENT AS PROOF THAT I EXERCISED MY RIGHTS TO REMAIN SILENT AND HAVE AN ATTORNEY PRESENT OR CONSULT WITH OVER THE PHONE BEFORE I WILL ANSWER ANY QUESTIONS OTHER THAN MY NAME AND ADDRESS. THANK YOU FOR RESPECTING MY RIGHTS AND STOPPING ALL QUESTIONING AS THE SUPREME COURT HAS SAID YOU MUST.
